- II. Celebrating What God Has Done Jason Peck, Next-Gen Pastor
  - Daniel Evans shared that in June 2023 the Worship Ministry took 23 participants to Angel Fire, New Mexico, working with a local church during their VBS. They were also involved in leading worship for the church during a community outreach event.
  - Jason Peck shared that the Next-Gen Ministry has had a busy summer, over 200 participated in a family movie night; they took 72 Kids and volunteers to CrossTimbers Camp; 24 to Super Summer; 104 to Falls Creek Camp where there were 5 salvations, 7 recommitted their life to Christ, and some felt God was leading them into full-time ministry. Also, this summer we had 440 students and volunteers involved in VBS, with over 500 attending family night. The Student Ministry just returned from a mission trip to Nicaragua, they had 16 participate in the mission.
  - The average worship attendance in quarter one for the last three years has been: 2021 765; 2022 837; and 2023 857.
  - New members for quarter one are: 6 by baptism, 3 by statement, 10 by letter, totaling 19.
